This product is produced without the use of any excipients or processing aides, rendering it a non-chemically altered version of its seed base. This allows us to declare that the product has been in the food supply since before October 15, 1994 and therefore not a "New Dietary Ingredient". This product is safe for human consumption based on the aforementioned conditions.
